In modern States taxes are the most widespread and perceived expression of State's power. This makes taxes the best pillar of State's democracy level. The evolution changing societies so profoundly in last two centuries, has also affected every aspect of taxation: substantial, administrative and procedural.

Taxes are nowadays still an inevitable limitation of personal freedom. Nonetheless, since taxes are the only means modern democracies have to finance themselves, they have paradoxically become the most important tool to defend and grant those same freedoms.

For these reasons taxes are now the result of the relationship between three different ideas: personal freedoms, which represents the essence of every human being and the purpose of modern democratic States; fair

taxation, which is achieved by granting personal freedoms and equality when sharing public expenditures; tax morale, which is the taxpayers willingness to pay their share of public expenditures and it is so intimately linked to the respect of personal freedoms and to the equity of the whole tax system.

Modern taxation is so deeply soaked with these three ideals that there is no tax nor even economic policy that does not face them and deeply depends on how they relate to each other and to taxes.

Our speakers will address these topics, including changes in business, society, and institutions. We will talk about the new relationship between people and administrations and how the focus is more and more on person rather than taxpayer.

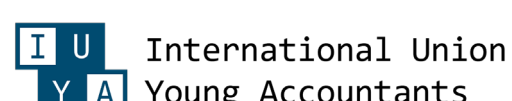
